What data do we collect?

Our Company collects the following data:

- Personal identification information: Name, email address, phone number and home address (minimum required information is your city and country).
- Your new address (minimum required information is the city and country).
- Your proposed move date.

How do we collect your data?

You directly provide Our Company with most of the data we collect. We collect data and process data when you (or the moving company that you enquire with):

- Registers a request for a virtual pre-move survey through our online dashboard and/or website.
- Verbally during the virtual pre-move survey.

Our Company may also receive your data indirectly from the following sources:

• The moving company that you enquire with.



How will we use your data?

Our Company collects your data so that we can:

- Send you a confirmation e-mail and calendar invitation for your virtual pre-move survey appointment as well as a courtesy reminder message via email and/or text message.
- Prepare a comprehensive pre-move survey report for the moving company that you enquire with, enabling them to provide you with an accurate proposal for your move.
- We may need to email you with follow up questions regarding your inventory or other relevant information regarding your move.

We will NOT email you with information about other products / services that may be of interest to you and we will NOT share your data with any other partner companies.

How do we store your data?

Our Company securely stores your data in Google Cloud SQL, leveraging a globally distributed infrastructure that ensures high availability and disaster recovery. Data is encrypted at rest using Google's built-in encryption and in transit with SSL/TLS, safeguarding your information from unauthorised access. Access to the data is strictly controlled through Identity and Access Management (IAM) policies, requiring multi-factor authentication and role-based access controls to ensure that only authorised personnel can view or manage your data. Additionally, our infrastructure undergoes regular security audits and complies with top industry standards (such as ISO/IEC 27001), providing you with a secure and reliable environment for your valuable information.



Our Company will keep your personal and transactional data for a maximum period of 12 months. Once this time period has expired, instead of deleting your data, we will anonymise it for record-keeping purposes. This anonymisation process involves removing or modifying personal identifiers and other identifiable information, so the data can no longer be associated with you or any individual. The anonymised data is then used for analytical, regulatory compliance, and research purposes, helping us to improve our services while ensuring your privacy is maintained. This process is aligned with privacy laws and regulations, ensuring that we handle your information responsibly and securely throughout its lifecycle.

Marketing

Our Company will NOT contact you for marketing purposes of any kind.

Video Recordings

The core activity of our company is to provide you / your chosen moving company with a virtual move consultancy service. This means that you will have a recorded video call with one of our trained move consultants who will obtain all relevant information from you in order for your chosen moving company to be able to provide you with an accurate proposal for your move. This consultation may include questions regarding move dates, property availability dates, visa requirements, insurance valuations, etc.

During the video call you will be asked to show us everything that you require to be moved (e.g. furniture, contents of cupboards/wardrobes, etc., boxes that you may have packed already, plants, removable features & fittings, vehicles, etc.).

The video recordings are stored securely and are only accessible to authorised personnel at our company who will review the footage in order to complete your move itinerary and at request also to your chosen moving company.

You may request a copy of the video recording for your personal use within 90 days from your virtual consultation.



Video Recordings - Security & Privacy

Our company uses a bespoke software for video recordings that is GDPR Compliant (General Data Protection Regulation).

All media (video and audio) are stored with Heroku servers using industry best practices.

Media is automatically stored for a maximum of 12-months. Files can be deleted at any time upon request.

The platform's user dashboard is secured with login credentials and utilises 2048 Bit SSL Certificates with 256-bit AES encryption at all touch points.
